A. Updates from SC Co-chairs


- a. Lt. Gov: Overview of today's meeting agenda and the activities and forms to be completed to prepare for the G3 Biannual meeting at the virtual Conference for Island Sustainability on April 6th. More information on the expectations and level of participation from the SC for the Biannual meeting will be discussed in March.
 - i. The new Educational Stabilization Funds are dedicated to creating more digital content and learning resources to expand the curriculum for all grade levels. This is something that could be leveraged in most if not all of the categories if additional resources were needed in that area. My office is available to assist with this.

 - i. Updates on the work of the G3 core team at UOG CIS
 - 1. A proposed budget and activities to be carried out with the funding provided by the appropriated funds from the Recycling Revolving Fund was submitted to the Guam EPA board recently. Received tentative approval subject to their legal counsel's review.

 - i. This is a short 10-minute survey that will be used by our partners to share with other interested in our process and the G3 team for future planning and reporting.

 - C. Biannual meeting content
 - a. First half - Formal, chaired by Gov. and Pres. Krise, press event, opportunity for partners to see progress, high level view, report out, what can we solve collectively through G3?
 - i. Highlight to the community what issues we are solving and what issues we can continue to solve through G3 with the information provided in the report out of the quadrant form.
 - b. Second half - Steering committee meeting led by SC Co-chairs, open working meeting, technical focus on G3 categories of action and next steps
 - D. Updates from Team Leads
 - a. Healthy and Prosperous Communities
 - No updates to report. Would like to request the support to engage public health to provide the information that is needed.

- The new administrative support member assigned to the team will provide assistance for this effort
- b. Educated, Capable, and Compassionate Island
 - i. We plan to infuse in everything associated with the reopening of schools including the continuity aspect, and identifying the areas where no data was collected during 2020 (ex: some student assessments).
 - ii. The prioritization levels in the framework will be referenced in our plans for the use of the ESF money.
- c. Sustainable Homes, Utilities, and Transportation
 - i. Updates to be provided another time as the lead was not present.
- d. Thriving Natural Resources
 - i. We'll submit our updates and the forms requested. Our Youth Ambassador Kyle will provide an update on his progress.
 - 1. A youth network of organizations that share a focus on addressing the climate crisis has been established through some of the schools and advocacy groups. Will be reaching out to the superintendent to include all of the schools on island and to local businesses directly.
- e. Sustainable Alliances
 - i. The recent mass exit of our Micronesians neighbors from the Pacific Islands Forum is something to take note of, however there is still some representation in the Micronesians Islands Forum.
 - ii. 500th anniversary of the Magellan-Elcano circumnavigation is this Friday, and along with it some diplomatic opportunities for engagement.
 - iii. Finalizing the plans for G3 houses at Chamorro Village as well as our new partnership to manage the recyclables and green waste materials for the entire Village.
- f. Data and Public Engagement team
 - i. Successful report out from the presentation from ESRI and HGG recently.
 - ii. UOG OIT, OTEC, and ESRI are continuing their conversation on who would be the license holder for the dashboard. UOG would be granted educational sites access that GovGuam would not.
 - iii. HGG and ESRI gave information on what we can work on in the meantime.

1. A crosswalk of the SDGs and the 5 categories of action has been created to help determine our primary indicators of success in meeting our development goals.
 2. We can begin building the dashboard with our top 5 indicators to track and the sub indicators that would tell the story of our progress.
 3. The template is set up so that we can begin here and grow our dashboard in the future.
