# A. Updates from SC Co-chairs

- a. Lt. Gov. Tenorio G3 work is being globally recognized, notably through Global Island Partnership (GLISPA)
  - G3 branding will be used for the projects under Dept. of Public Works that promotes safer streets, starting with the village of Santa Rita. G3 logos will be on safety signs and literature.
  - ii. Kyle Mandapat and G3 team will work with Clearinghouse to ensure branding is appropriate
- b. Dr. Shelton echoed recognition of the G3 work. Lt. Gov. Tenorio is now a Steering Committee member of GLISPA and Gov. Leon Guerrero a GLISPA leader, an important leadership role for Guam in the global movement for island sustainability
  - i. Update on G3 projects:
    - G3 Conservation Corps applications are open on https://guamgreengrowth.org/jobs/ until Saturday, May 29, 2021 for 12 positions focusing on sustainability projects and workforce development. Already received several applications. Designed as a pilot and will continue to look for more local and federal grant funding, especially with the developments of Biden's Climate Corps initiative
    - G3 Community Garden met with Sen. Tina Muña Barnes to build a community garden at the old Dept. of Administration property over the summer, in partnership with Guåhan Sustainable Culture and AmeriCorps to promote food security
    - 3. G3 Makerspace + Innovation Hub Precious Plastics machines and space to be ready in the next few months

- 4. Plastic Bag Ban Outreach in partnership with GEPA
- 5. G3 Commitment (Annania) awarded SDG 1 and SDG 2 badges to the mayors of Piti, Dededo, Agana, and Sinajana with the help of the UOG MPA cohort. Mangilao, Mongmong-Toto-Maite, Inarajan, and Agat are currently in the process of committing and receiving these badges. Working on getting the rest of the villages and businesses into the program, in conversation with 3 businesses
  - a. Continue to work with mayors like providing recycling bins through RRF in partnership with iRecycle and installing waste receptacles in parks in partnership with Dept. of Parks and Recreation
- ii. New team member Kyle Mandapat, Asst. Director of Communications at UOG CIS
- iii. Recap: Micronesia Challenge Virtual Forum (Vangie and Trina)
  - To celebrate the accomplishments of the 15 years of conservation work in Micronesia. The event was hosted in partnership with G3 and GLISPA, Trina Leberer was Emcee and Gov. Leon Guerrero and leaders of Micronesia were present. Reached over 4,000 views on Zoom and the FSM Facebook live stream. Led to invitation for G3 and UOGCIS to partner with GLISPA to cohost more exciting virtual events in the global network.
